- 6) This First Time Affiliation to start B.A.M.S. (UG) course with **100** intake capacity is valid for Academic Year **2025-26** only.
- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college/Institute.
- 8) The college shall not admit the students for the Academic Year **2025-26** after the cut-off date prescribed by the CCIM / (NCISM), New Delhi.
- 9) The students shall be admitted only after obtaining the permission of concern council & competent Authority of the State Govt.
- 10) It is mandatory for the College / Institute to register on AISHE portal and submit the required data on AISHE portal time to time.
